Safeguarding:

The Trust and its schools aim to safeguard and promote the welfare and well-being of its children and young people. Its focus is on ensuring good outcomes for all children are achieved and support the principles underpinning the children's Acts of 1989 and 2004 and Keeping Children Safe in Education 2023 and Working Together to Safeguard Children 2018.

Each school has its own specific children protection policy. All sites have a DSL or DDSL and use CPOMS to report and record safeguarding incidents.

Behaviour and Antibullying:

We firmly believe that providing our students with imaginative and appropriate teaching and learning experiences is the most effective way of promoting positive behaviour. We recognise that our ever-changing pupil community present with a varied range of needs and that it is our responsibility to ensure that alongside our whole school code of conduct and school rules we recognise the individuality of each student and their stage of development. We carefully plan learning experiences to match the needs of each child and deal with behaviour issues likewise in a holistic and supportive manner. We recognise that a good behaviour policy reflects the vision of the school and enhances the quality of relationships found in the school, promoting mutual respect, courtesy, esteem, and a preparedness to learn in a safe and effective working atmosphere. Positive behaviour is always acknowledged and rewarded. Negative behaviour is always dealt with, and sanctions issued.

SEND:

We recognise the need to provide an inclusive, supportive and positive learning environment. The skill, enthusiasm and supportive attitude of the class teacher is the key to effective learning of all students. High quality teaching, differentiated for individual pupils is the first step in responding to pupils who have SEND. The SEND policies are produced in response to the Special Needs Code of Practice 2002. The new Code of Practice provides statutory guidance on duties, policies and procedures relating to Part 3 of the Children and Families Act 2014 and associated regulations and applies to England. It relates to children and young people with special educational needs (SEND). All pupils should be given equal opportunity to develop their talents and abilities to their full potential both inside the classroom and outside. At all stages, the wellbeing of the individual is paramount. These aims are met by a whole-school approach to September 2022 Special Educational Needs provision with all teaching staff taking responsibility for meeting individual needs. Trips and Visits and transporting pupils to and from sites:

Oakwood Academy and Kassia Academy both run provisions that are split across multiple sites. Both schools use the Evolve system to review and approve trips and visits. These policies apply to all educational visits, outdoor learning and adventurous activities carried out with young people. The Headteacher appoints an Educational Visits Co-ordinator who have the training and experience to enable them to competently discharge their responsibilities.
